Introduction

Medannot is committed to protecting personal data and adheres to GDPR and relevant privacy laws. This document outlines Medannot's policies and practices for data privacy.

Medannot is startup focused on providing AI-driven medical imaging solutions. Their platform offers secure, browser-based access to advanced 3D modelling tools, primarily aimed at supporting healthcare providers, researchers, and academic institutions. By leveraging cloud infrastructure (specifically AWS) and tools like Terraform for infrastructure management, Medannot ensures high availability and security for its systems, with strong data protection measures through AWS Security Hub, CloudTrail, GuardDuty, and daily data backups. Medannot's services support enhanced surgical planning, patient education, and data-driven research, facilitating a collaborative and innovative approach to medical diagnostics and AI research.

We understand that you are aware of and care about your own personal privacy interests, and we take that seriously. This Privacy Notice describes the Medannot's policies and practices regarding its collection and use of your personal data, and sets forth your privacy rights. We recognize that information privacy is an ongoing responsibility, and so we will from time to time update this Privacy Notice as we undertake new personal data practices or adopt new privacy policies.

How we collect and use (process) your personal information

Medannot collects limited personal data, such as name, job title, email, and phone, primarily to deliver services. Data collected is solely for Medannot's services and not shared or sold without consent. Occasionally, Medannot may receive additional information from third parties like LinkedIn to enhance user experience.

Medannot collects personal information about its website visitors and customers. With a few exceptions, this information is generally limited to:

- name
- job title
- employer name
- work address
- work email
- work phone number

We use this information to provide prospects and customers with services.

We do not sell personal information to anyone and only share it with third parties who are facilitating the delivery of our services.

From time to time, Medannot receives personal information about individuals from third parties. Typically, information collected from third parties will include further details on your employer or industry. We may also collect your personal data from a third party website (e.g. LinkedIn)

Use of the Medannot Website

As is true of most other websites, Medannot's website collects certain information automatically and stores it in log files. The information may include internet protocol (IP) addresses, the region or general location where your computer or device is accessing the internet, browser type, operating system and other usage information about the use of Medannot's website, including a history of the pages you view. We use this information to help us design our site to better suit our users' needs. We may also use your IP address to help diagnose problems with our server and to administer our website, analyze trends, track visitor movements, and gather broad demographic information that assists us in identifying visitor preferences.

Medannot has a legitimate interest in understanding how members, customers and potential customers use its website. This assists Medannot with providing more relevant products and services, with communicating value to our sponsors and corporate members, and with providing appropriate staffing to meet member and customer needs.

Cookies and tracking technologies

Medannot makes available a comprehensive cookie notice that describes the cookies and tracking technologies used on Medannot website and provides information on how users can accept or reject them.

Medannot's website uses cookies and similar tracking technologies. Users are informed about cookie usage and provided options to accept or reject cookies in the cookie notice.

Sharing information with third parties

The personal information Medannot collects from you is stored in one or more databases hosted by third parties located in European Union and United States. These third parties do not use or have access to your personal information for any purpose other than cloud storage and retrieval. On occasion, Medannot engages third parties to send information to you, including information about our products, services, and events.

We do not otherwise reveal your personal data to non-Medannot persons or businesses for their independent use unless: (1) you request or authorize it; (2) it's in connection with Medannot-hosted and Medannot co-sponsored conferences as described above; (3) the information is provided to comply with the law (for example, compelled by law enforcement to comply with a search warrant, subpoena, or court order), enforce an agreement we have with you, or to protect our rights, property or safety, or the rights, property or safety of our employees or others; (4) the information is provided to our agents, vendors or service providers who perform functions on our behalf; (5) to address emergencies or acts of God; or (6) to address disputes, claims, or to persons demonstrating legal authority to act on your behalf. We may also gather aggregated data about our services and website visitors and disclose the results of such aggregated (but not personally identifiable) information to our partners, service providers, advertisers, and/or other third parties for marketing or promotional purposes.

The Medannot website connects with third party services such as Facebook, LinkedIn, Twitter and others. If you choose to share information from the Medannot website through these services, you should review the privacy policy of that service. If you are a member of a third party service, the aforementioned connections may allow that service to connect your visit to our site to your personal data.

Transferring personal data to the U.S.

Medannot may transfer and process data in the United States or other non-EU locations, adhering to GDPR standards through measures like standard contractual clauses.

Medannot has its headquarters in Slovakia. Information we collect about you will be processed in European Union and United States. By using Medannot's services, you acknowledge that your personal information will be processed in the United States. The United States has not sought nor received a finding of "adequacy" from the European Union under Article 45 of the GDPR. Pursuant to Article 46 of the GDPR, Medannot is providing for appropriate safeguards by entering binding, standard data protection clauses, enforceable by data subjects in the EEA and the UK. These clauses have been enhanced based on the guidance of the European Data Protection Board and will be updated when the new draft model clauses are approved.

Depending on the circumstance, Medannot also collects and transfers to the U.S. personal data with consent; to perform a contract with you; or to fulfill a compelling legitimate interest of Medannot in a manner that does not outweigh your rights and freedoms. Medannot endeavors to apply suitable safeguards to protect the privacy and security of your personal data and to use it only consistent with your relationship with Medannot and the practices described in this Privacy Statement. Medannot also enters into data processing agreements and model clauses with its vendors whenever feasible and appropriate. Since it was founded, Medannot has received zero government requests for information.

Data Subject rights

Medannot respects data subject rights under GDPR, including access, rectification, erasure, data portability, and objection to processing. Individuals can exercise their rights via our designated privacy contact.

The European Union's General Data Protection Regulation (GDPR) and other countries' privacy laws provide certain rights for data subjects. Data Subject rights under GDPR include the following:

Medannot respects data subject rights under GDPR, including access, rectification, erasure, data portability, and objection to processing. Individuals can exercise their rights via our designated privacy contact.

- Right to be informed
- Right of access
- Right to rectification

- Right to restrict processing

This Privacy Notice is intended to provide you with information about what personal data Medannot collects about you and how it is used.

If you wish to confirm that Medannot is processing your personal data, or to have access to the personal data Medannot may have about you, please contact us.

You may also request information about: the purpose of the processing; the categories of personal data concerned; who else outside Medannot might have received the data from Medannot; what the source of the information was (if you didn't provide it directly to Medannot); and how long it will be stored. You have a right to correct (rectify) the record of your personal data maintained by Medannot if it is inaccurate. You may request that Medannot erase that data or cease processing it, subject to certain exceptions. You may also request that Medannot cease using your data for direct marketing purposes. In many countries, you have a right to lodge a complaint with the appropriate data protection authority if you have concerns about how Medannot processes your personal data. When technically feasible, Medannot will—at your request—provide your personal data to you.

Reasonable access to your personal data will be provided at no cost. If access cannot be provided within a reasonable time frame, Medannot will provide you with a date when the information will be provided. If for some reason access is denied, Medannot will provide an explanation as to why access has been denied.

Data storage and retention

Medannot retains customer data during active service relationships and securely deletes it afterward. Retention periods are defined for both customer and prospect data, ensuring secure handling and deletion upon request.

Your personal data is stored by the Medannot on its servers, and on the servers of the cloud-based database management services the Medannot engages, located in the United States. The Medannot retains service data for the duration of the customer's business relationship with the Medannot and for a period of time thereafter, to analyze the data for Medannot's own operations, and for historical and archiving purposes associated with Medannot's services. Medannot retains prospect data until such time as it no longer has business value and is purged from Medannot systems. All personal data that Medannot controls may be deleted upon verified request from Data Subjects or their authorized agents.
